## FACILITY USAGE INFORMATION

Group Drop In access includes the Aquatics Center, Gymnasium Complex, and public areas during scheduled public open hours. Activities and drop-in classes are available for an additional fee. All Kroc Center Rates and Policies must be followed during visit. **All guests must bring their own swimsuits (no shorts) and towels. Only white or grey t-shirts may be worn over swim suit. Children not toilet trained must wear a swim diaper. Fees must be paid prior to or at time of entry, unless other arrangements have been made with Kroc Management.**

Guests age 18 and younger who would like to use the facility must have an adult, age 19 or older, sign the minor guest's waiver and pay applicable guest fees.

**Ages 6 & under:** One chaperone must be present for every four children. Chaperone must actually be in the pool within arm's reach of children.

**Ages 7-11:** One chaperone must be present for every eight children. Chaperone must stay in the same area of children during visit.

**Ages 11 and under:** Require supervision by an accompanying guest 16 and older at all times.

**Ages 12-16:** One chaperone must be present for every 15 children. Chaperone must stay in the same area of children during visit.

**Ages 16 & older:** May use the facility without chaperone present at all times.

**Adults 19 & older:** Required to show state-issued Photo Id and sign The Kroc Center's Liability Waiver.

\* **Please note: no outside food or beverage allowed.**

\* **Use of RJ's Adventure Zone play area not guaranteed and requires socks for all participants.**
